Those elements which did survive, and merited some archaeological consideration, were the air-raid shelter, the buried remains of the colliery buildings and the remnants of the colliery spoil tip. Additionally, investigation of the boundary of the former deer park along the southern edge of the study area would be desirable. [Au(abr)]
