The archaeological potential of the study site for the Palaeolithic is thought to be very low and for the later prehistoric periods (Mesolithic, Neolithic, Bronze Age and Iron Age) is thought to be low with a low archaeological potential for the Anglo Saxon, early medieval, late medieval and post-medieval periods to c. 1650 when it lay in agricultural or horticultural land. The site lies immediately adjacent to the Winchester Palace scheduled ancient monument area (no. 28) and within one of the Borough of Southwark's Areas of Archaeological Importance. Further, the eastern curtilage wall of Soho Wharf may be founded on a medieval foundation which originally supported the western end of the medieval palace's northern service range. In the medieval and early post-medieval period the Clink Prison may have occupied the site. [Au(adp)]

Potential archaeological deposits consist, in summary, of in situ prehistoric remains, buried intact beneath later of peat or alluvial silts, possible evidence for structures, land/water interface management and agriculture of the Roman Period, possible evidence for medieval land-use, including agricultural soils, quarry pits and to a lesser degree, later medieval structures representing encroachment onto Horselydown, post-medieval burials within the churchyard of St John Horselydown, and the remains of post-medieval buildings.
