The survey and assessment revealed that the walled garden at Gawthorpe was significant as a late Victorian/Edwardian kitchen garden. In itself it could be described as being locally important, although the fernery was a very attractive feature in its own right and was said to be a significant element of regional or national importance. The fern house at Gawthorpe was typical of the designs in the 1880–1890s when ferns were very popular. The fernery would have been the main entrance into the walled garden for the family and their visitors and this important approach was highlighted by the wonderful view of the uplands to the north from the entrance. It remained a very unusual and highly significant element of the walled garden design and was perhaps the single most impressive feature on site. Parts of the walled garden were in very poor condition and needed management action of some kind immediately. Other components had survived as relicts in a reasonable or stable condition.
