The ditch was aligned north-west to southeast, the pit and post holes north-east to south-west. These not only demonstrated the excellent standard of preservation within the monument, they also suggested that evidence of internal sub-divisions, possible entrance ways and structural remains, were preserved within the interior of the monument.
