 uncovering several archaeological features, sealed beneath the topsoil. In Trench 1, two gullies and a
 post hole were identified at the north-east end of the trench. The fills of the features contained abraded
 Roman pottery, and it seems probable that these features were of Roman date. The trench also
 contained three very shallow linear features, running across the centre; these were presumed to be
 remnants of cultivation furrows, possibly of medieval date. A single sherd of medieval green-glazed
 pottery was recovered from above the furrows, within the topsoil. In Trench 2, the central cultivation
 furrow was seen to continue on into the trench at the north-western end, and at the south-eastern end,
 one of the two Roman gullies was identified again, cutting across the eastern corner of the trench. In
 the centre of the trench a subrectangular cut was identified, possibly a truncated pit. The deposits were
 sealed by a layer of dirty clay, containing large quantities of Roman tile, and sherds of Roman pottery.
 This in turn was sealed by a deposit of redeposited natural clay. The pit may have served as a rubbish

Several Bronze Age burnt mounds were found in good condition, some in pairs, which might be considered for future surveys. Traces of Romano-British settlement were observed but were ploughed over, masking their form. No pottery of this era was found and only patches of field systems of this date, however, a large quern of this period was discovered. Medieval style complicated curved bank and ditch boundaries were noted, some within the park, some outside of it. Potential hedged landscape. Remnants of straight hedge-banks raised the issue of dating. Early industry, represented by mining, ore processing smelting of both iron and lead ore, particularly on Slitt and Allergill Veins. Two of the evaluation trenches were situated within St. Hilda's graveyard, which had been truncated by the realignment of the Coronation Street and the construction of a dredge pumping station. A number of broken gravestones, pieces of grave furniture, and large quantities of disarticulated human bone were recovered from these trenches, indicating a high level of post-medieval disturbance. Fourteen graves were revealed in one of the trenches, relating to at least two phases of burial activity dating to the eighteenth and early nineteenth centuries. A single trench was excavated directly to the north of Mill Dam, which revealed the foundations of a substantial industrial structure and contaminated ground water below ground level. It was not possible to determine whether earlier archaeological features survived beneath these deposits. The majority of finds dated to the eighteenth and early nineteenth centuries. [Au(abr)]
