Blackburn cathedral developments commissioned an archaeological evaluation of the south-east parts of the cathedral precinct in response to outline development proposals for this area. Three trial pits were hand excavated while three boreholes were also monitored. The work was carried out under an approval granted by the Cathedrals Fabric Commission for England. No significant archaeological remains were encountered in the south east corner and southern margin of the site, suggesting that these areas had relatively low potential. A buried ledger slab was found in the trial pit on the lawn to the south of the cathedral nave along with a fragment of human skull in an adjacent soil layer, which was clearly disarticulated. The other evaluated areas were also part of the extended churchyard but there was no evidence for burials in those areas. [Au(adp)]
