Below this level pre-modern deposits were encountered, becoming waterlogged with depth. Quantities of animal bone were recovered, including the large part of a cow skeleton, but the only datable material comprised very small quantities of abraded Romano-British and medieval pottery mixed within the same deposit. The waterlogged levels exhibited good survival of palaeoenvironmental material, including organic matter and plant macrofossils, but these derived from deposits which were not securely dated. An archaeological project involving trial excavation was undertaken on a site comprising the former Robinson Building and Nos. 157-159 East Street, Bedminster, as part of the planning process. The project was part of a phased programme of archaeological work on the site. This involved the excavation of five archaeological evaluation trenches. Four of the trenches were located inside the standing buildings of Nos. 157-159 East Street and the fifth trench was located to the south east of Nos. 157-159 East Street in an area of car park associated with the Robinson building. Trenches 1-4 revealed natural bedrock immediately beneath the shop floor. Only Trenches 2, 3 and 4 contained archaeological deposits, all of which proved to be minor post-medieval rock-cut features. An exploratory test pit at the front of the property revealed a cellar of probable Victorian date. A section of wall exposed in the shop front suggested that the natural bedrock was terraced away for the construction of the shop fronts in the 20th century. Trench 5 contained the remains of two post-medieval walls, probably the same wall truncated at a later date, part of a modern drain structure and two post-medieval cut features. The natural bedrock in Trench 5 was located at a depth of approximately 2.3m (13.91 m above O.D.) and below a deep sequence of soil deposits. Although a handful of residual Roman and medieval pottery sherds were recovered from this trench, the majority of ceramics dated to the post-medieval period. The earliest archaeological deposits identified in Trench 5 therefore dated to the post-medieval period. A large assemblage of animal bone was also recovered. Despite the close proximity of a 17th to 18th century Clay Tobacco Pipe factory (BSMR 22406) and the supposed site of an Anglo-Saxon Minster, no evidence of these was located in Trench 5. On the basis of the evidence recorded during the project, it was concluded that the archaeology located on the site was of only low potential and not of national or regional significance. In view of this, it was advised that no further detailed archaeological work was justified on the site prior to redevelopment. However, a watching brief was recommended in order to ensure that all unforeseen archaeological deposits that may have been revealed during the course of redevelopment groundwork were recorded prior to their destruction. Evaluation was undertaken in three fields (Areas 1 to 3) and comprised the machine-excavation of 28 trenches totalling 1,610m². The work revealed features and deposits dating from the early Bronze Age, Iron Age, medieval and post-medieval periods, although in many trenches largely negative results were recorded. Prehistoric features were generally concentrated on the south-west side of the site, and included a curvilinear feature containing Beaker-type pottery and a faience bead, and stone-filled linear features and/or pits of the same date. A large ditch close to these contained middle to late Iron Age pottery. A substantial north-west to south-east aligned negative linear earthwork was also located in the south-west half of the site, with excavation revealing this to be a substantial ditch with a later central recut. A single sherd of medieval pottery was recovered from the recut, suggesting that an existing landscape feature was being re-utilised at this time. The north-west part of the site contained mainly post-medieval features, although localised areas of prehistoric and medieval archaeological activity were also present. The post-medieval deposits appeared to be largely associated with a former building complex shown in this location on a map of 1838, which had been removed by 1869. Evidence comprised a wall of a possible agricultural building, metalled trackways and cobbled and metalled

surfaces. It was considered that the south-west side of the site contains probably the densest concentration of features and perhaps the most significant archaeological evidence on the site. Features in this area indicated prehistoric settlement and agricultural activity and also hinted at the possibility of funerary deposits being present.
