A programme of archaeological monitoring and recording at Marks Warren Quarry, Whalebone Lane North, Romford was undertaken. Previous archaeological investigation in the area had identified prehistoric activity, including an Iron Age ditched enclosure, a Roman enclosure, the flint foundations of a Roman building and a Late Iron Age/Roman field system, late Bronze Age/early Iron Age pits, post holes and a Bronze Age barrow, Late Iron Age cremations and pits, Saxon cremations and a ditch, post-medieval drainage ditches, post holes and 20th century activity. The 2008 archaeological investigation identified four phases of activity. Phase 1 comprised Late Bronze Age/Early Iron Age ditches, possibly part of an enclosure, pits and post holes. Phase 2 was Roman and comprised a cremation, pits and possibly a ditch which formed part of an enclosure. Phase 3 evidence consisted of a single medieval post hole. Post-medieval and modern activity was assigned to Phase 4 and included ditches, pit, field drains and a plough damage layer. Several undated features were identified across the site. [Au(abr)]

Excavations at Embassy Court revealed a sequence of archaeological remains related to settlement on the Roman road of Watling Street. To the west of the site, an arrangement of post holes and beam slots was interpreted as representing the remains of a roadside building, the full size of which was not revealed as it extended beyond the western limits of the trench. In the east of the trench, up to six cremation burials were observed cut into the natural stratigraphy. It was suggested that additional burials may have been found beyond the eastern extent of the trench. Separating the proposed structure in the west and the cremations in the east was a large, north to south ditch cut. An east to west ditch was also noted, but was not thought to be a roadside ditch. Finds within this layer dated to the Roman period and included pottery and ceramic building material. Several late post-medieval intrusions were recorded cutting this layer, including a north-south drain run, presumably belonging to the Embassy ballrooms, as well as a large rectangular feature of unknown function that contained peg-tile within its fill. A watching brief was undertaken in 2008 on an area to the west of the new Wembley Stadium, London. The project was undertaken in association with a programme of geo-technical investigations. The investigations involved the observation and recording of five window samples and two machine excavated geo-technical test pits. All five window samples presented a sequence comprising a layer of rubble-rich made ground overlying redeposited London Clay and naturally deposited London Clay. The two test pits had made ground; only in one of them naturally deposited London Clay was uncovered. It was thought that horizontal truncation took place prior to the deposition of the made ground, removing any previously existing subsoil deposits. The horizontal truncation of deposits was thought to have occurred during the development of the site in the early 20th century. The disturbed nature of all the deposits indicated that the potential for archaeological horizons to survive in these areas was very poor. The investigation comprised a limited field evaluation followed by a watching brief of concrete slab removal, power-auguring of proposed pile locations and excavation of a lift shaft pit area to naturally occurring geological deposits. The significance of an east-east running palaeochannel observed in the area could not be understated [sic]. It gave a unique insight into the environmental conditions that existed in this part of London prior to the settlement of the area by prehistoric and Roman communities. The backfilling of this course appeared to have begun before human occupation began in the locality. Overlaying this was a layer of silt and domestic waste, with timber posts driven through. These were interpreted as structural in nature, or perhaps the revetment of a drainage ditch. Another arrangement of timbers may have suggested further structural remains. The report presented a summary of archaeological work carried out at the site in advance of an anticipated future development. A large Iron Age oppidum ditch was found in the north of the site, together with two smaller associated ditches in the north-west of the site. The main ditch was dated by optically stimulated luminescence [OSL] to c.500-100 BC, and showed a gradual silting up that meant that it would still have been visible in the medieval period. Two 14th century London Ware kilns were excavated in the south-east of the site, one of which was exceptionally well preserved and displayed progressive development from an original double flue layout to a single flue design. Large quantities of pottery wasters were also recorded. In the northern part of the site, the oppidum ditch had been truncated by medieval and post-medieval building along the frontage of Warren Lane. In the area behind the houses on Warren Lane, two Tudor period kilns and an early medieval kiln were excavated together with numerous associated pits and post holes. Elsewhere there was little or no survival of the 16th century Rope Yard buildings remaining, although occasional remnants of 18th-19th century buildings were found.
