1: Executive Summary

The following summary has been drawn from the research findings section of the report.

Public Health

- 22% of EDDC panel members have a dog
- 93% of members agree that dog control is an important issue
- 39% of members disagree that dogs should be kept on leads at all times
- 81% agree that there should be a dog ban in certain areas
- 68% agree that there should be more "No fouling" signs
- 71% agree that fines for fouling should be higher
- 72% agree that there should be more bins for dog waste
- 34% disagree that locations for dog bins are adequate
- 34% agree that dogs bins aren't emptied frequently enough

Community Safety

- 94% of panel members feel safe living in their neighbourhood
- 93% of panel members feel safe walking alone in the day
- 63% feel safe walking alone at night
- 96% of members don't have a problem with noisy neighbours
- 81% don't think people hanging around on the streets is a big problem
- 83% don't think there is a problem with people being drunk in public places
- 89% don't think there is a problem with drug dealing or use
- 68% don't think there is a problem with rubbish and litter lying around
- 74% don't think vandalism, graffiti or property damage are much of a problem
- 89% and 85% of members are not aware of the Crime & Disorder Reduction Partnership or the Community Partnership respectively

Moors Valley Country Park & Open Spaces

- 84% of panel members have visited MVCP
- Of those that haven't 40% say they are not attracted to what's on offer
- Of those that have visited 88% are satisfied with it as an enjoyable day out
- 63% know about MVCP through local knowledge
- 28% of members tend to visit every 6 months, only 4% go weekly
- 33% go to MVCP all year round
- 94% of members have access to a vehicle
- 71% of members go to MVCP by car

- 89% and 77% of panel members are not aware of either Norcat or X36 bus services respectively
- 52% of members are aware of the off road access from the B3081, 50% are aware of Potterne park access and 53% are aware of Castlemaine trailway access however only between 20% and 27% of members use them
- 23% of members tend to visit other open spaces once in 6 months
- 81% are satisfied with open spaces provided locally
- 51% are satisfied with information about open spaces
- 42% are satisfied with the Council's ability to promote open spaces
- 53% are satisfied with the Council's ability to keep public land clear of litter
- Moors Valley, Potterne Wood, Stephens Castle, Dewlands Common, Leigh Common, Poor Common and Walford Mill are the best known and visited open spaces in the district
- 62% of members are satisfied with cultural facilities in the area
- 54% are satisfied with sports and leisure facilities

Young People

- 40% of members are dissatisfied with services for young people
- 79% and 68% of members are not aware of either www.eastdorsetarts.org or Summer Blast as info sources for kids activities
- Of those activities used or visited 51% of Adults and 58% of children rated them good to some extent.
- 68% haven't heard of East Dorset Youth Council
- 52% of members think that young people do have a voice on issues affecting them
- 51% would like to bring issues affecting them to the forefront of policy
- 73% would like to improve facilities for young people
- 96% have never visited a EDYC meeting
- 77% would attend if they were held locally

Communication

- 69% of members think that the Council keep residents well informed about its services
- 67% think that its easy to find out about the Council
- The Local free paper is the preferred info source (34%) and 53% have used Council Tax statements and word of mouth and 49% have used East Dorset News
- Those that prefer leaflets as an information source prefer to pick them up from the Library (73%) and the Post Office (66%)
- 45% of members receive every edition of the East Dorset News through their door
- East Dorset News has a good rating overall by 70% of members
- 53% of panel members have never visited the Dorset for you Website

- Of those that have 39% rate it good overall
- 84% of members have not sought advise in the last 6 months
- Of those that did seek advise 54% gave a good rating

Elections

- 97% of members vote
- Between 55% and 89% vote at all the different elections
- 85% of members rate their local polling stations as good in all respects
- 77% of panel members voted in the May 2007 elections
- The strongest reason for voting was because they wanted to have a say in who won the election (81%) of those not voting 9% wanted to vote but were unable to for some reason or other
- 60% of members know what the responsibilities are of their local councillor
- Only 15% of members have ever considered standing as a councillor.
- 40% would stand as a councillor if they had more time and if they thought they could make a difference

2: Introduction

2.1: East Dorset District Council Consultation

Consultation, including Best Value and Citizens' Panel research, is the mechanism by which Local Authorities can monitor and quality and cost of services it provides for the public, and investigate issues of importance to local residents.

Assessing the views of residents is key to this process, so East Dorset District Council has embarked on a full and sustained public consultation programme so that any decisions made are in line with public opinion, and so that communities are more involved in the decision making process.

2.2: East Dorset Panel Talkback Survey 13

This report details the full results of the thirteenth East Dorset Citizens' Panel Survey. In this case the survey sought to collect intelligence about outdoor services and facilities. Please note that many of these areas have been surveyed previously, and so trends may be identified in the behaviours and opinions of residents.

Questions were asked on; facilities for young people, cleaning and litter services and dog fouling, Moors Valley Country Park and open spaces, election and councillors, general safety, information provision by the Council and cultural facilities. The results of these questions will be used to aid future decision making in these service areas.

2.3: The Market Research Group (MRG)

East Dorset District Council has commissioned the Market Research Group (MRG), based at Bournemouth University, to undertake this research. MRG aims to be a key independent resource for the provision and interpretation of market intelligence for its clients.

The group offers expertise, experience and advice in the field of market research, tailored to suit the needs of individual organisations. MRG has specialised in consultation of this sort, and has numerous projects to its name.

2.4: Project Aims & Objectives

2.4.1: Project Aims

The project's research aim was to provide the Council with reliable information about the behaviour and views of residents with regards to the aforementioned topics. The results of the research will help the Council make informed decisions about future service delivery and priorities.

2.4.2: Project Objectives

More specifically, the project sought to achieve the following objectives:

- To assess opinions of dog fouling.
- To assess opinions on Moors Valley and other open spaces
- To assess opinions on general safety
- To assess opinions of services for young people.
- To assess opinions on peoples voting and thoughts on Councillors and their responsibilities
- To collect any other relevant comments and suggestions.
- To identify any significant differences between respondent types.
- To identify any trends in these results over time and between the Council and peer organisations (where possible).

3: Methodology

3.1: Target Population

In this case, the target population (those of interest to the research) was all residents living in the East Dorset area.

3.2: Sampling & Response

A census sample of target population would be near impossible to organise and conduct within the timeframe and budget of this research, so a sampling technique was required, whereby only a selected sample of residents take part in the research. The East Dorset Citizens' Panel is a representative sample of residents, which was set up using a random sampling technique, for this purpose.

The Panel is made up of 625 residents, 355 of which responded to the research within the fieldwork period (57% response rate).

3.3: Data Collection

Data collection is the method used to administer the research. Given the objectives of the research, the size and nature of the Panel, it was determined that a postal and on-line survey were the most appropriate. This also had the advantages of:

- The respondent's confidentiality was assured, especially as independent researchers had been used.
- Fieldwork costs and schedules were reduced significantly due to a lack of human interviewing involvement.
- Respondents were able to complete the questionnaire at their leisure, and look up information relating to their past behaviour if necessary.
- Respondents with e-mail could complete on-line providing instant data therefore reducing data entry costs

The questionnaire was distributed to Panel members via the post on 20th September 2007, including a covering letter explaining the purpose of the survey, completed by respondents and returned to MRG using a freepost return envelope by 8th October 2007. Due to a Royal Mail strike the deadline was then extended for another week to maximise responses. Also to maximise the response rate respondents were sent reminder postcards towards the end of this fieldwork period.

3.4: Questionnaire Design

The questionnaire (see *Appendix 6.4*) was designed by MRG, in conjunction with the Council, specifically to fulfil the research objectives of this project. The questions included; pre-coded (tick response), open-ended, rating and ranking questions. All survey responses were analysed in conjunction with general demographic data held on respondents by MRG.

3.5: Data Analysis

A standard coding system was used, where each response is assigned a numerical value for ease of data analysis within a specialist computer programme.


Tabulations, cross-tabulations and other statistical calculations (averages) were then produced to satisfy the information requirements of the Council. These can be found in the appendices, along with a list of verbatim comments (see *Appendices 6.1*, *6.2* & *6.3*).

4: Research Findings

This section of the report discusses the findings of the survey. Specifically, it deals with; Dog fouling, general safety, Moors Valley Country Park and other open spaces, services for young people, Information provision by the Council and Elections. A profile of respondents to the survey may be found in the appendices, along with the original tabulations and verbatim comments.

4.1: Public Health


These specific questions have not been asked before and therefore there are no figures to compare with.



4.1.1 Dog ownership

22% of panel members have a dog. This is quite a high rate of dog ownership as the National figure according to Mintel (2005) is 19.8%. Unsurprisingly this figure is higher in the rural areas of East Dorset at 30%. Dog ownership is lowest in West Moors at only 12%. 45-64 year olds are the age group with the highest dog ownership at 27%

4.1.2a: Dog Control



In most cases the following results are combined to give an overall positive or negative rating.


93% of members agree to some extent that dog control is an important issue. Dog owners feel more strongly (67%) about this than non dog owners (60%). This feeling is strongest in West Moors at 100% and unsurprisingly lowest in Rural areas at 88%.

4.1.2b: Dog on leads at all times




39% of members disagree that dogs should be kept on leads at all times. Non dog owners feel more strongly (25%) about this than owners (10%). West Moors is the ward that feels strongest about this issue (87%).

4.1.2c: Dog ban in certain areas




81% of members agree that there should be a dog ban in certain areas. St Leonards feels most strongly about this issue (89%).

4.1.2d: No fouling signs




68% agree that there should be more "No fouling" signs. West Moors (86%) feels more strongly that its area should have more "No fouling" signs than other Wards.

4.1.2e: Fouling fines should be higher




71% agree fines should be higher. Corfe Mullen (81%) feels more strongly about higher fines than other Wards.

4.1.2f: More bins for dog waste



72% of panel members agree that there should be more bins for dog waste. St Leonards has a greater desire for more dog bins (84%).

4.1.2g: Location of dog bins is adequate



34% of members disagree that locations for dog bins are adequate. St Leonards disagrees with this statement the most at 48%.

4.1.2h: Dog bins are not emptied is frequently enough



34% of members agree that dog bins aren't emptied frequently enough. Verwood appears to agree with this more than other areas (38%).

4.1.3: Which areas are worse affected by dog fouling?



Local streets, roads, lanes and alley ways are where most members feel dog fouling is the greatest problem. The full list can be found in the appendices.

4.2: Community safety





94% of members feel safe living in their neighbourhood. This feeling is highest in Wimborne & Colehill and Corfe Mullen where no one feels unsafe. This overall figure has dropped slightly from March 2006 when 96% of members agreed that they felt safe to an extent.

4.2.4b: How safe do you feel walking alone during the day?



93% feel safe walking around during the day. Again this has fallen 2% from 95% when asked in March 2006. All members in Corfe Mullen feel safe walking alone in the day.



4.2.4c: How safe do you feel walking alone at night?


63% feel safe walking alone at night. This has dropped 12% a significant amount from the 75% recorded in 2006. Corfe Mullen (77%) has the most members who feel safe walking alone at night and Ferndown (49%) has the least people who feel safe at night.

Being scared of groups of youths is the main reason for feeling unsafe.

4.2.6a: How much of a problem are noisy neighbours?




96% of members don't have a problem with noisy neighbours. This is an improvement of 5% since the last survey in 2006 at 91%. Interestingly the Rural (7%) areas are fractionally more concerned about noisy neighbours than other Wards.

4.2.6b: How much of a problem are people hanging around on the streets?




81% of panel members don't think people hanging around on the streets is a big problem. This has significantly changed since March 2006 when only 59% of members thought this was not a fairly or very big problem. St Leonards has no problem with this issue; however 28% of Ferndown members do have a concern about people hanging around the streets.

4.2.6c: How much of a problem are people being drunk or rowdy?




83% of members don't think this is a big problem, back in March Only 64% of members didn't think that people being drunk and rowdy was a big problem. St Leonards has no problem with this issue; however, 24% of Wimborne & Colehill members consider drunkenness and rowdy behaviour to be a problem.






89% do not think drug using or dealing is a big problem. This again has increased from only 48% of members in March 2006 who thought it wasn't a big problem. Drug issues are not a problem to members in St Leonards whereas 18% of West Moors members feel drug taking and dealing is a big problem.

4.2.6e: How much of a problem are rubbish and litter lying around?



68% of members don't think there's a big problem with litter lying around. Back in March 2006 only 61% thought this so another improvement. 44% of Ferndown members feel that litter is a big problem whereas St Leonards has the least problem (83%)

4.2.6f: How much of a problem are vandalism, graffiti and damage to property?



74% of members don't think this is a big problem, whereas in March 2006 only 53% thought vandalism wasn't a problem an increase of 21%. Interestingly vandalism, graffiti and damage to property is a bigger problem for members in Rural areas (36%). St Leonards has the least problems with vandalism etc...

4.2.7: Are you aware of the Partnership websites?



89% and 85% respectively are not aware of the websites Crime & Disorder Reduction Partnership and Community Partnership. Rural areas are slightly more aware of these partnerships than other Wards.

4.3: Moors Valley Country Park & Open Spaces





84% of panel members have been to Moors Valley. Members in Verwood are more likely to have visited MVCP. Members in Corfe Mullen are less likely to have visited.

4.3.9: If "No," why is this?

40% of members who haven't been to MVCP say it's because they are not attracted to what is on offer. Members from Ferndown have a bigger issue with the cost of parking as to why they don't go than other wards. Members in Wimborne & Colehill feel more strongly about not being attracted to what's on offer there.

Of those who don't go to MVCP and that ticked "other" the following are the main reasons. No reason to go or not suitable for them is the main reason.


4.3.10: If "Yes," how satisfied were you with it as an enjoyable day out?





















































4.6.55: Did you vote at the last Government Election on 3rd May 2007?





4.6.56: Which of the following statements applies to you for your reasons for voting or not voting?





4.6.58 Have you ever considered standing as a local Councillor?





5: Summary

Public Health

There is quite a high percentage of dog ownership in East Dorset with rural areas and 45 to 54yr olds having the highest ownership. Dog control issues are of concern to all members and these are most prevalent in West Moors where there is a higher proportion of people who think they should be on leads. Members in St Leonards feel more strongly that there should be a dog ban in certain areas and West Moors obviously has more concerns about dog fouling and more signs are needed. Corfe Mullen believes that fines should be higher and St Leonards feels the need for more dog waste bins as the current locations are not adequate. Wimborne & Colehill have an issue with how frequently bins are emptied.

Community safety

There has been a very slight decrease in members feeling safe in their neighbourhood; this appears to be more of a very slight concern in rural areas and especially when walking alone at night in West Moors. Ferndown has a slightly increased problem with people hanging around on the streets than other areas and Wimborne & Colehill has a slightly inflated risk of drunk and rowdy behaviour. Drug use and dealing is not a big issue in East Dorset however Ferndown members consider it to be of more of problem there than anywhere else along with rubbish and Littering. Vandalism is a bigger concern in rural areas whereas St Leonards has very little damage or graffiti. There is still not a very great awareness of the Partnership Websites.

Moors Valley Country Park

Most members are aware of MVCP and are satisfied with it as an enjoyable day out. Members in Corfe Mullen are less likely to visit probably due to their location and lack of public transport. The vast majority learn of MVCP through local knowledge. Members do not visit MVCP very regularly however they do visit all year round. The average duration of stay at MVCP is 2.7 hours where people enjoy the open space for walking and enjoying the peace & tranquillity. The majority travel by car to MVCP as they don't consider the alternative facilities to be convenient or they are not aware of the alternatives like the bus routes. Many prefer the independence of getting their under their own steam but resent the high car parking fees. Other open spaces in East Dorset are not visited anymore frequently than MVCP and certainly this regularity has decreased since the 2006 survey. However the vast majority of members are satisfied with parks and open spaces if not a little ambivalent towards information provision and their promotion. Members knowledge of the full extent of parks and open spaces available to them is not as good as it could be. There is slight in decrease in satisfaction levels for Cultural facilities which is worse in St Leonards and Ferndown and more notably sports and Leisure has lower satisfaction levels in these wards.

Young People

There is not a great satisfaction in facilities for young people and this is most notable in St Leonards and rural areas. More youth clubs and activities with reduced charges would help. There is a need to make people aware of the sites that promote kids activities in order to show them wants on offer.

Again there is not a great awareness of the East Dorset Youth Council which again would help assist young people in discovering what's available for them. There would be a better attendance at EDYC meetings if they were held locally. Better provision of youth clubs and drop in centres are required.

Communication

Ease of finding out about the Council has dropped a little perhaps some issues with the telephone service were to blame and some poor or inadequate information provision for some members. Free local papers remain the preferred method of info provision. Leaflets are not greatly used but when they are members like to pick them up from Libraries and Post offices. The circulation of EDN appears top have increased and members would like more planning applications and decisions published in it.

Awareness of the Dorset for you website has improved along with its overall rating and ease of navigation but the main reason for not using remains as a lack of computer or internet knowledge and or ability. Members want more information in free local papers and a newsletter.

Elections

Less members voted in the 2007 election then in 2003. Members are quite well aware of Councillors responsibilities and very slightly more members stood as a councillor than in 2006. The most fulfilling part of those that stood was the enjoyment of helping people and influencing decisions. Members said that they would be more encourage to stand if the were younger.

- I'm pleased you continue to canvass opinions.
- I appreciate the opportunity to meet county & district councillors at parish level and, although of a different party I appreciate their dedication to their work.
- I believe residents want more say in planning development or enhancement issues relating to Ferndown centre & Victoria Road. I would like to see & hear a councillor would object to the proposed high density housing proposed at Dormy hotel site & at West Parley. In other words, "protect our environment" from further development.
- I believe the issue of control of dogs & the mess they leave to be a
 important issue. Additionally, Wimborne Minster used to have an individual
 to clean the streets. He took pride & the streets were always clean. The
 mechanical machine now used is noisy, inefficient, pollutes & is not up to
 the job. Cigarette ends are also becoming a major problem as in disposal of
 chewing gum.
- I feel strongly that there should be more affordable housing in the Wimborne area, & permission given for the building of houses as long as a significant percentage are of the style & amount that young people (early earners) can afford.
- I have always felt very strongly about car park charges at MVCP. They are too high & deter me from going.
- I have tried at various times to raise the issues of parking outside key industries, Ebblake i.e... Along Blackmoor Rd & around corner. Also beside hatched areas, which forces traffic onto wrong side of road, unsighted. A serious accident is imminent. Double yellow lines needed. Rubbish in Ebblake T.E. needs regular collection, including the fringes dumped in the brook. The footpath/pedestrian way in Ebblake T.E. is AGAIN very overgrown & needs attention. Some footpaths in P.M. estate are grassed over with shrubs etc. These are impassable for disabled & pushchairs & need to be tarmaced. Many drivers take wrong route around miniroundabout in P.M. estate. Arrows?? Garden maintenance in P.M. estate is poor, sub-contractors NOT fulfilling their contract.
- I know that I may appear to be banging on about the place names of Q25, but it might be useful to know what maps to use for reference. I should imagine that not many people have reference to ordnance survey maps which may or not be used by yourselves. I think a mention of what maps you use could be useful if you wish meaningful answers.
- I think it is important that you have feedback from the electorate on the services offered, and that this survey will prove productive.
- I think leisure should be more affordable to the disabled and low income people. More dog waste bins needed in areas where people walk their dogs.
- I think we are extremely fortunate to live in East Dorset & hope that the council continues to flourish & support the general public.
- I would like to see better maintenance of roadside hedges & edges. For the sake of wheelchairs & pedestrians. There are places along many areas

where passing along the pavement is very difficult, even for the sighted & fit people. Home owners should be made aware and requested by the council to clear any obstruction along the pavement. Car sales at hilltop, Stapehill being a typical example. Cars on pavements, both sides of the road in St James Road. Also, a clear view to exit this road is often blocked.

- Information is there if people take the trouble to look.
- I think the website name "Dorset for you.com" is rather trendy & silly. What was wrong with a (meaningful) name like "eastdorset.gov.uk" which adheres to a naming standard & exactly shows what it's for? Please use a spell checker on the form. Be careful about over-promoting small, quiet, open spaces or they may be spoilt by too many visitors.
- It is sometimes impossible to use a postal vote. The voting forms are released so close to the election that there is insufficient time to receive and post the form. Prices for lifting large items of refuse (e.g... Garden furniture) are too high. This encourages fly dumping. The library is not adequate for a town the size of Verwood Verwood is no longer a village. MVCP appears to be aimed at visiting holidaymakers rather than local residents. I do not like to see the council wasting money through inefficiency e.g. sending out this form twice! Apart from the colour I noticed no difference. Be advised that Q47 that the noun should be used. Q18 The nearest the X36 bus gets to MVCP is 3 Legged Cross. MVCP is not on the bus route in my opinion.
- It saddens me that this survey is necessary because what we have in this
 area (both naturally & via the council) should be more than sufficient for us
 all and if everyone was more caring & responsible for themselves & for
 others, extra provisions & money could be devoted for the needy few.
- It would be a lovely idea if Moors Valley gave discount to local residents on yearly parking ticket - say give 13 months for local residents & 12 months for people living outside area.
- It would be helpful if some paths in the countryside were not rutted so deeply & the undergrowth cut back more frequently. Some stiles are in need of repair. Without a car it is not possible to reach the railway station for earlier trains not to go home after 5.30pm unless waiting for a taxi. No public transport to the Tollard Royal countryside not to Shaftsbury.
- It would be helpful if the electoral role compilers could in some instances use council tax details. I have been on electoral role 9 to 10 years completing all forms which electoral role compliers had. Yet suddenly for no apparent reason they had my apartment void in May 2007.
- Like to see all plastic recycled please.
- Living in this part of the country we are lucky to have an abundance of open spaces. Listing them, as in this questionnaire can be misleading as it could be construed that one is interested to a large degree. This is not the case, but I am unlikely to regularly visit those listed in other parts of the district, but that doesn't mean they should be neglected as they have a function for the particular areas they serve.
- Local council is not interested in council tax payer. Things do not get attended to even if things are pointed out to them. They make no effort to stand up for more money from central government & do not seem bothered. We are lowest funded in the country. Council tax rates go up every year at alarming rate & services get worse. EDDC is only interested in council estates & youth matters. OAP's are just a nuisance.

- Many resident, & especially pensioners, are stretched to the limit on living costs & can't afford to pay increased council taxes.

- Not sure how large an area is "the area in which you live". Standards vary considerably from one road to another. Young people impossible to answer this if no children around in the family no box to indicate this.
- Only yesterday a neighbour told me of a lady living alone & being bothered by youths climbing over her gate & entering her garden at night. Feeling very afraid they were going to try to break into her home she phoned the police. The police response was "we are very busy".

- Q2. Please may there be a bin for dog waste in Churchmoor Rd entrance to Bytheway field.
- Q25 My previous employment prevented me from choosing to visit many of the places named, & I was unaware so many open spaces existed. I have never seen such a list before (or don't remember seeing such a list). Q6 Householders should cut back hedges overhanging pavements & preferably sweep their own pavement. When roads are too be swept householders notified so area (one side) maybe left car free to ensure effective sweeping. I live in what has been called Wimborne's "railway town" & consider the roads/pavements dirty & gardens overgrowing the public footpath. In Grove Rd one vehicle has been "parked" for over one year & so a small garden is growing in the gutter between vehicle & pavement.
- Re. dog fouling how are the fines enforced? Open areas are well maintained. Re. Q25 I looked on the council website, and these areas are listed, but it doesn't say where they are!
- Re. safety. My wife & I are elderly (early 70's but still physically able. However, we are "stay at homers". Therefore our comments are based on observations made within a rather small, limited area. Accordingly, we are not (as yet) troubled by many of those factors that blight the wider parish in noticeable trouble spots. We are probably typical & possibly not very helpful. For instance, we do not walk about at night, so we cannot comment about such problems as may be applicable elsewhere, such as in the township of

Wimborne. With due apology. Re. MVCP. We used to be regular visitors, but the high parking charges are now a deterrent. Our answers are therefore historic i.e. based on when we used to go there until about two years ago.

- Reduce or eliminate parking charges at WCMP. Brook Road refuse centre MUST be made more user friendly for older folk. Enforce speed limits on Cranborne/Wimborne Road entry into Wimborne by better signage or cooperation with police.
- Road signs. Keeping them visible to the public by cutting back vegetation safety!
- St Ives is an area with many pine trees which at this time of the year create
 a lot of pine needles in the roads, which block the drains & are slippery
 when wet. Better more frequent road sweeping required especially in the
 close.
- Thank you for the opportunity to show I care about conditions of housing, way of life to all who live, work or go to school in Wimborne.
- The bus service in the part of Corfe Mullen (east) is almost extinct. One bus to Wimborne at 9:05 return at 12:00 weekday. We have to walk 1/3 of mile to nearest stop at Lockenys school. Unless we use the 9:05 & walk back to go into Wimborne we have to change at Broadstone. I have written numerous letters to bus company. Spoke to councillors at parish & county and have had considerable letters from parliamentary representative with no avail. In fact one service from Lockyers school has now been discontinued & we are virtually cut off unless we use a car. So this survey is almost useless to us.
- The placing of council & parish notices in the community is poor. Tatty notice boards in unsuitable locations. The location should be prime where everybody goes e.g. by a supermarket. There should be a bay or alcove not a notice board exposed to the weather. Each of the activities financially supported by the council should have opportunities to display their activities e.g. E.D.H.T. & Q.E. Each town/parish should have such a location. We have a high quotient of active people in the community & they deserve a higher participation of passive members.
- This questionnaire does not address the following with regard to Ferndown.
 1. Traffic speed in Albert Rd. Cars have been seen to travel in excess of 50mph.
 2. No traffic wardens. People with disabled badges, parking on pavement in Victoria Road.
 3. Street cleaning in area of Albert Rd/St Mary's Close very limited.
- To get usage of MVCP up and to get more people into Open Spaces, target fathers specifically. These areas are ideal for dads to take children for walks - would help the health of the adult too! Target PTA's, young wives groups, single parent support groups etc. To raise awareness of open spaces; encourage walking groups to include them on their walks. Continue to develop idea of guided walks to include Open Spaces other than MVCP.
- Verwood has grown dramatically over the years but little has been done for the youth/leisure. Roads have been added/redirected against the will of the majority. We feel we have no power in decisions made in Dorchester in connection with the closure of the crossroads junction. i.e. no entry to Manor Rd & Edmondston Rd & Ringwood Rd. We would welcome a questionnaire about the expansion of houses.

- We would all like to see more real police and traffic wardens everywhere.
- We would like more support in how to claim a council tax rebate as the forms are so complicated and personal that we gave up.
- I get more information from Poole than East Dorset.
- What a waste sending two surveys, we had completed the white one & apart from colour difference on the two.
- Worthwhile exercise.
- Young people. Sort out the sports facility in the Ferndown area. EDDC spent a lot of money on QES, however, Ferndown?? It should be pulled down & a sports centre like the Littledown put in it's place. Then the younger/middle people would have a very good sports centre. The older persons seem to like Ferndown. Well, what about the rest of us. Also, we need better public transport. Suggest EDDC puts our money where it's mouth is!
