Two archaeological evaluation trenches were investigated on the site. In trench 1, two brick cellars that fronted onto the Tapster Street frontage were recorded, in addition there was a brick well and two brick-lined cess pits, which were 19th century in date. There were also several post-medieval land raising dumps. In Trench 2, an undated shallow cut into the natural gravel was present. This may have been a quarry cut or represent terracing. It was sealed by an undated soil horizon, above which was a post-medieval land raising dump. Fourteen auger holes were drilled, which formed four transects across the predicted line of the moat. The transects lay within the footprint of the proposed synagogue, but outside the limit of the Scheduled Ancient Monument (SAM). The archaeological auger survey has confirmed the predicted line of the moat and bank illustrated in the Archaeological Impact Assessment (Bowsher 1999) and has been able to refine the alignment of the feature to some extent. It is likely that the moat follows a line that runs slightly obliquely across the footprint of the proposed building. Thus, in the southern part of the school footprint, it is likely that the moat lies almost entirely within the SAM with the bank extending below the footprint of the building itself.
