All of the deposits encountered consisted of loose to very loose layers of redeposited slate fragments. Other than a rock cut ditch and the edge of a possible ditch, no archaeological features or structures were exposed. There was a general paucity of finds, which consisted of eight sherds of 19th/20th-century pottery, recovered from the fill of the ditch. [Au(adp)]

Trenches amounting to 4.4% of the defined area were excavated, which revealed some localised areas of modern disturbance, and evidence that landscaping had taken place during construction of the fuel tanks. Two curving stone surfaces of an 18th or 19th-century date were recorded. These features were not depicted on historic maps. No evidence for archaeological activity pre-dating the post-medieval period, in the form of features or finds, was identified in any trench. [Au(abr)]

Trenches C, D, and E produced evidence of post-medieval agricultural use of the site in the form of earlier cultivation soils and a slate-lined land drain. At least one of these pre-dates the engine shed, and probably also the construction of the south range of the stables. The other feature was an unusual, stone-lined sheep burial of probable 18th/19th-century date. The most likely explanation for this is that it was the

The absence of any archaeological features across the area investigated suggested that the proposed development lay within a relatively sterile archaeological environment. The shallow topsoil contained a sparse assemblage of post-medieval domestic china and pottery. These sherds had most likely been incorporated into the soil via manuring or ploughing activities, rather than indicating occupation on the site or in the close vicinity. [Au(abr)]
